## REGULAR SESSION

The Governing Body met in Regular Session in the City Council Chambers. Mayor Joe Andrasek called the meeting to order at 7:30 p.m. with the following present: Councilmembers Andrew Erb, Vicki Berryman, Cory Zimmerman, Jolene Biggs, Joel Jackson, Corey Urban, Dan Heath and Brock McPherson. Also in attendance were Interim City Administrator George Kolb, City Attorney Robert Suelter and City Clerk Shawna Schafer.

### A. CONSENT AGENDA

- a) **Minutes:** Minutes of the Regular Session held on May 21, 2018.
- b) **Claim's Warrant Register #6-4-18:** covering 2018 bills to date in the amount of \$472,435.82.
- c) **Payroll Register P/R 5-25-18** covering payroll ending May 19, in the amount of \$366,867.37.
- d) **Appointments:** Mayor Andrasek made no appointments.
- e) **Charlie Suchy Resignation.** Charlie Suchy has resigned as Public Works Director as set out in a letter attached to the distributed agenda. The resignation to be accepted.
- e) **Agenda:** Approval of agenda as submitted.

Mr. Erb made a motion to approve the consent agenda. The motion was seconded by Mr. Heath and passed by a vote of 7-1 with Mr. McPherson voting no.

B. **OLD BUSINESS:** There was no old business.

C. **RECOGNITION OF VISITORS AND ANNOUNCEMENTS:** There were no visitors or announcements.

### D. NEW BUSINESS

1. **Councilmember Reports:** There were no councilmember reports
2. **Administrator's Update:** Interim City Administrator Kolb distributed his monthly report regarding the activities of the various City departments.
3. **Economic Development Report:** Chamber President/CEO Jan Peters presented her monthly report.
4. **Abatement Requests:** City Sanitarian Austin LaViolette presented the following abatements to the Governing Body:

- a. **1622 Nineteenth Street.** Trash and refuse including, but not limited to, a discarded sofa,, discarded tires, a discarded water heater, plastic containers and other trash and refuse are located on the real estate at 1622 19<sup>th</sup> Street constituting an unlawful accumulation. This real estate is the subject of Resolution Number 060418-A.
- b. **819 Stone Street.** Trash and refuse including, but not limited to, a discarded mattress, discarded tires, general trash, scrap metal and other trash and refuse are located on the real estate at 819 Stone constituting an unlawful accumulation. This real estate is the subject of Resolution Number 060418-B.
- c. **821 Holland.** A silver Pontiac automobile not bearing current registration is located on the real estate at 821 Holland constituting a motor vehicle nuisance. This real estate is the subject of Resolution Number 060418-C

Mr. Jackson made a motion to adopt Resolutions Numbered 060418-A, B and C. The motion was seconded by Mr. Erb and passed with all voting in favor.

5. **Request to Hook on City Sewer:** City Inspector Lee Schneider that Richard G. Suchy has signed a request to hook onto the City's sewer for real estate owned by him outside of the City limits. He has signed the appropriate request form and consent to annexation. Aaron Suchy had signed the original request but he was not the owner of the real estate. That has been corrected. The hookup is for a building to be constructed on the real estate that is designed with only one toilet on the premises and will be used for private use. Mr. Zimmerman made a motion to approve the application and permit hooking onto the sewer line after meeting all city requirements and the owner paying for all associated costs. The motion was seconded by Mr. Urban and passed by a vote of 6-2 with Mr. McPherson and Ms. Berryman voting no.

#### **E. ADJOURNMENT**

Ms. Biggs made a motion that the meeting be adjourned. The motion was seconded by Mr. McPherson and passed with all voting in favor. The meeting was adjourned at 7:48 p.m.
