SPECIAL MEETING

The Governing Body met in a special meeting to discuss employment issues currently facing the City. Present were Mayor Allison, Councilmembers Mike Boys, Allene Owen, Wayne Henneke, Vicki Berryman, Joel Jackson, Dana Dawson, Cory Zimmerman and Brock McPherson.

Mayor Allison called the meeting to order. Mr. Boys made a motion to recess to executive session for a period of one hour to discuss employment matters currently facing the City, personnel matters of non-elected personnel, which executive session shall include all Governing Body members, Special Counsel Ed Keeley, City Attorney Robert Suelter, Police Chief Clifton Couch, City Administrator Howard Partington and his attorney Tom Berscheidt with the regular meeting to resume at 7:00 p.m. in the council chambers. The motion was seconded by Ms. Berryman and passed with all voting in favor.

At 7:00 p.m. the Governing Body resumed its meeting. Mr. Henneke made a motion to recess to executive session for a period of one hour to discuss employment matters currently facing the City, personnel matters of non-elected personnel, with the same parties attending as in the previous motion, with the regular meeting to resume at 8:00 p.m. in the council chambers. The motion was seconded by Mr. Dawson and passed with all voting in favor.

At 8:00 p.m. the Governing Body resumed its meeting. Mr. Boys then made a motion to recess to executive session for a period of thirty minutes to discuss employment issues currently facing the City, personnel matters of non-elected personnel, which executive session shall include all Governing Body members, Special Counsel Ed Keeley and City Attorney Robert Suelter, with the regular meeting to resume at 8:30 p.m. in the council chambers. The motion was seconded by Ms. Berryman and passed with all voting in favor.

At 8:30 p.m. the Governing Body resumed its meeting. Mr. Boys then made a motion to recess to executive session for a period of fifteen minutes to discuss employment issues currently facing the City, personnel matters of non-elected personnel, which executive session shall include all Governing Body members, Special Counsel Ed Keeley and City Attorney Robert Suelter, with the regular meeting to resume at 8:45 p.m. in the council chambers. The motion was seconded by Ms. Berryman and passed with all voting in favor.

At 8:45 p.m. the Governing Body resumed its meeting. Mr. Jackson made a motion to direct the City Attorney and Special Counsel Ed Keely to locate a firm to conduct a compensation study and management study on the Great Bend Police Department. The motion was seconded by Mr. Dawson and passed with all voting in favor.

There being no further business, Mr. McPherson made a motion to adjourn. The motion was seconded by Ms. Owen and passed with all voting in favor. The meeting was adjourned at 8:46 p.m.


1. Executive Session: An Executive Session is requested to discuss the employment issues currently facing the City, personnel matters of non-elected personnel.
