REGULAR SESSION

The Governing Body met in Regular Session in the City Council Chambers. Mayor Joe Andrasek called the meeting to order at 6:30 p.m. with the following present: Councilmembers Andrew Erb, Vicki Berrryman, Cory Zimmerman, Jolene Biggs, Joel Jackson, Corey Urban, Dan Heath and Brock McPherson. Also in attendance were Interim City Administrator George Kolb, City Attorney Robert Suelter and City Clerk Shawna Schafer.

A. CONSENT AGENDA

- a) **Minutes:** Minutes of the Regular Session held on June 18, 2018, and the Budget Session held on June 11, 2018.
- b) **Claim's Warrant Register #7-2-18:** covering 2018 bills to date in the amount of \$807,823.64
- c) **Payroll Register P/R 6-22-18** covering payroll ending June 16, 2018, in the amount of \$394,500.50.
- d) **Appointments:** Mayor Andrasek made no appointment.
- e) **Street Closure:** Close McKinley and 17th Street Terrace Starting at 9:50 a.m. for the wet/dry parade.
- f) **Street Closure:** Close 17th Street Terrace west of McKinley to White Sands Drive after the parade to midnight to utilize for extra parking and allow one-way traffic to be directed to the west and have the street completely closed to all traffic except for car show.
- g) **Party in the Park Fireworks Display:** Allow the discharge of fireworks in Vets Park on Saturday, August 11, 2018, by contracted officials starting around 10:00 p.m. and allow the consumption of 3.2% beer, in metal containers only, at the event.
- h) **Non-Street Legal Cars:** Allow non-street legal cars that are local car club affiliated to be able to preregister and travel no more than 12 blocks to get to the Party in the Park Car Show.
- i) **Vets Park Curfew Extension:** Authorize people to be in Vets Park past midnight on Saturday, August 11, 2018, for cleanup of the Party in the Park event.
- j) **Wine in the Wild Event:** Request withdrawn.
- k) **Agenda:** Approval or agenda as submitted or amended.

Mr. Urban made a motion to approve the agenda as amended by the deletion of Item j. The motion was seconded by Mr. Heath and passed with all voting in favor.

B. **OLD BUSINESS:** There was no old business.

C. **RECOGNITION OF VISITORS AND ANNOUNCEMENTS:** There were no visitors or announcements.

D. **NEW BUSINESS**

1. **Councilmember Reports:** There were no councilmember reports.

2. **Administrators Update:** Interim City Administrator George Kolb presented his monthly updated/

3. **Economic Development Report:** Chamber President/CEO Jan Peters presented her monthly report.

4. **Abatement Requests:** City Sanitarian Austin LaViolette presented the following abatement to the Governing Body:

- a. **220 Heizer:** Trash and Refuse including , but not limited to two discarded sofas as well as other general household trash is located on the real estate at 220 Heizer constituting an unlawful accumulation. This real estate is the subject of Resolution Number 070218_A.

Mr. Erb made a motion to adopt Resolution Number 070218-A, B. The motion was seconded by Ms. Biggs and passed with all voting in favor.

5. **Regular Council Meeting Start Time Change Ordinance.** City Attorney Robert Suelter presented proposed ordinance number 4319 to change the time of the start of the regular city council meetings to 6:30 p.m. Mr. McPherson made a motion to amend the ordinance to reflect a 7:00p.m. start time. The motion died for the lack of a second. Mr. Urban then made a motion to adopt Ordinance Number 4319 changing the start time of regular City Council meetings to 6:30 p.m. The motion was seconded by Mr. Erg and passed by a vote of 7 to 1 with Mr. McPherson voting no.

6. **Request for Executive Session.** Mr. Urban made a motion to recess to executive session for a period of 45 minutes to discuss personnel matters concerning nonelected personnel for the review of candidates for City Administrator with the regular meeting to resume in the City Council Chambers at 7:45 p.m. The motion was seconded by Mr. Erb and passed with all voting in favor. At 7:45 p.m. the Governing Body returned to regular session.

Mr. Urban made a motion that the meeting be adjourned. The motion was seconded by Ms. Biggs and passed with all voting in favor. The meeting was adjourned at 7:45 p.m.
