## REGULAR SESSION

The Governing Body met in Regular Session in the City Council Chambers at 7:30 p.m. Mayor Mike Allison called the meeting to order with the following present: Councilmembers Dana Dawson, Vicki Berryman, Jolene Biggs, Joel Jackson, Allene Owen, Mike Boys and Brock McPherson. Councilmember Cory Zimmerman was absent. Also in attendance were Interim City Administrator George Kolb, City Attorney Robert Suelter and City Clerk Shawna Schafer.

### A. CONSENT AGENDA

- a) **Minutes:** Minutes of the Regular Session held on November 6, 2017.
- b) **Claim's Warrant Register #11-20-17:** covering 2017 bills to date in the amount of \$380,352.28.

- b. 708 Kansas. Trash and refuse including, but not limited to, a discarded sink, discarded hot water heater and discarded construction materials are located on the real estate at 708 Kansas constituting an unlawful accumulation. This real estate is the subject of Resolution Number 112017-B.
- c. 711 Morphy. Trash and refuse including, but not limited to, a trailer packed with household trash is located on the real estate at 711 Morphy constituting an unlawful accumulation. This real estate is the subject of Resolution Number 112117-C.
- d. 804 Adams. Trash and refuse including, but not limited to, discarded appliances, discarded furniture, scrap plastic, scrap metal, scrap lumber discarded construction material and household trash are located on the real estate at 804 Adams constituting an unlawful accumulation. This real estate is the subject of Resolution Number 112017-D.
